Paper submission

We are calling for papers within the following topics:

- Sustainable development, growth, poverty and inequality;
- Food security, rural and agricultural development;
- International and internal migration;
- Human capital and labour market;
- Natural capital and wealth accounting;
- Advances in impact evaluation and methodologies.

Papers focussing on cross-cutting theme as climate change, youth and disability, are particularly encouraged.

Papers must be written in English and only completed ones will be accepted.

The first page of the paper should include: i) submission title, ii) author/s' name/s and affiliation, iii) abstract (150 word max), iv) JEL classification, and v) detailed contact information (first and last name, mailing address, phone number, e-mail address) of the corresponding author.

All papers should be submitted in .pdf or .doc format to workshop2018@icid.info

All papers will be reviewed by a scientific committee.

Registration fees

Presenting authors are requested to register at SITES. Fees are as follows

- **Faculty Members** 60 Euro
- **PhD students and young post-doc** 30 Euro

Fee waivers can be requested. The organizing committee will review the request and decide, based on the total number of request and the availability of funds.

The fee should be paid/the request for a waiver should be submitted no later than September 12th, 2018. Payment instructions will be provided jointly with the notification of acceptance.
